

## Gloria T. Johnson Women in Union Leadership Scholarship Program

The purpose of the Gloria T. Johnson Scholarship Program is found in one of CLUW's founding principles — to "encourage and increase women's active participation in their unions" through support of women who want to learn and/or develop leadership skills. The program is designed to build and support a mentoring system that will help young women learn new skills so that they will be prepared to take leadership roles in their unions.

The Gloria T. Johnson Scholarship Program will provide a scholarship (or reimbursement) for costs of classes taken through an accredited labor studies program (up to \$1,000) to build mentoring skills for a union woman willing to serve as a mentor. The winner of the scholarship will agree to serve as a mentor to a young woman (or women) and/or an internship (at least 6 months in length).

The program is designed to inspire, provide support and be a complete experience for the scholarship winner as well as for a young woman (or women) who will be mentored or gain experience as an intern. The scholarship winner shall provide monthly, written reports on her work as a mentor, including activities, goals and outcomes.

The scholarship is available to union women and the children of union women (CLUW members and their children shall be given priority in the selection process). A commitment of time is required for the program. Applicants who have some experience as a mentor will receive credit for that experience.

- 2.Compose a written response (no more than 500 words) to one of the following questions and enclose as separate sheet with application indicating the question of choice with number:
  - A. How would you use the GTJ Scholarship to further your involvement with your union, build your leadership skills and support young union women?
  - B. What have you done to build your leadership skills and help others build their skills and experience?
  - C. How would you use the GTJ Scholarship to build and support a mentoring relationship with a young union woman —and/or design an internship for her?
